AMENDMENT TO ORDINANCE #136 - ZONING ORDINANCE

Change Section 3.2 - Official Zoning Map to read:

The property at 13320 Allman Road to be rezoned from Highway Service Commercial/Light Industrial to Suburban Residential.

AMENDMENT TO ORDINANCE #121 - SALARIES OF GENERAL LAW VILLAGE OFFICERS

Village President - \$500.00 annual allowance, \$50.00 meeting allowance

Village Clerk and Village Treasurer - 5% salary adjustment

Bookkeeper and Police Chief - 5% salary retro-active to 1st of year

Village Council - \$35.00 meeting allowance

Planning Commission - Chairman \$45.00 meeting allowance

Members \$25.00 meeting allowance

Park Board - Chairman \$20.00 meeting allowance, Members \$15.00 meeting allowance

Any member attending a meeting as a representative of the Village shall

be reimbursed at the same rate as the council or committee rate. This would included attendance at Mayor's Exchange, conferences, region meetings, etc. One half day of attendance is required in order to be reimbursed.

Car allowance for village business will be 35 cents per mile, unless using a village vehicle.

ADOPTED THE UPDATED ZONING ORDINANCE JUNE 9, 1992.

AMENDMENT TO ORDINANCE #141 - POLICE AND PUBLIC SAFETY ORDINANCE

Add to Chapter 9, section 9.5 the following:

I. No parking between the hours of 8 am to 6 pm, except Sundays and Holidays on the following streets:


1. South side of Railroad from North Union to North Concord.
2. East side of North Concord from Railroad to Hanover.
3. East side of North Union from Railroad to Hanover.
4. South side of Hanover from alleyway to east of Union.
5. North side of West Center from Spring to Maple.
6. South side of East Center from South Main to South Union.
7. South side of Monroe from South Main to Michigan.

J. An additional handicap parking space will be added in front of the Village Office;s garage door at 110 Hanover, at the beginning of the ramp on Hanover Street.

K. That 15 minute parking only be allowed from the Post Office's driveway, 112 Homer, west to Maple Street on the north side of Homer Street.

This amendment was adopted on July 27, 1993 and became effective August 26, 1993.

AMENDMENT TO ZONING ORDINANCE # 136:

Add to Chapter 4, Section 4.2.2 - Highway Service Commercial/Light Industrial District (HCI-2) the following:

4.2.2 B Conditional Uses:

12. Accessory uses or structures within the setback.

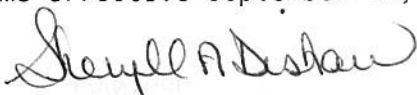
Add to Chapter 5, Section 5.5.10 - Additional Development Requirements for Certain Uses:

E. Accessory uses or structures within front setback must meet the following restrictions:

1. Any use or structure within the required front setback shall not obstruct view of traffic from adjacent lots.
2. Any use of structure within the required front setback shall not obstruct view of signs of adjacent businesses.
3. No portion of the highway right-of-way shall be used for any purpose.
4. Physical barriers such as: ditches, curbs, post and cable or any other permanent barrier not exceeding 24" above ground shall be installed to prevent parking within the highway right-of-way.
5. Site plan review in accordance with Section 5.6 shall be completed and approved.
6. If a structure is to be within 10 feet of the property line, a certified survey of the property shall be included with the site plan, and survey monuments shall be set along the property lines that are within 10 feet of the structure.

This amendment was adopted August 24, 1993 and became effective September 21, 1993.
