

AMENDMENT TO ORDINANCE #141 POLICE AND PUBLIC SAFETY:

Delete Section 9.6 reading "parking is prohibited along the North Side of Homer Street from Maple to Spring Streets."

Add Section 9.6 to read as follows: The parking space at the Northwest corner of Hanover Street at the intersection of Main Street to be handicapp parking only.

AMENDMENT TO ORDINANCE #136 - ZONING ORDINANCE:

Change Section 3.2 - Official Zoning Map to read as follows:

Lots 54, 55, 65 and 66 be changed from RU-1 Urban Residential to C1 - General Commercial District.

AMENDMENT TO ORDINANCE #141 POLICE AND PUBLIC SAFETY ORDINANCE:

Add Section 9.18 to create a Parking Violations Bureau, establish fine schedule and method of payment.

Section 9.18-1 Creation: There is hereby created a Parking Violations Bureau which shall be located in the Village Office and shall be operated by the Village Clerk. The Village Clerk is hereby empowered to accept admissions of responsibility for any parking violation citation issued by an authorized police officer. All expenses arising out of the operation of Parking Violations Bureau shall be borne by the Village.

Section 9.18-2 Violations: Charges or fines for parking violations shall be fixed by resolution of the Village Council.

Section 9-18-3 Payment: The Village Clerk shall issue a receipt in duplicate, one copy of which is to be given to the person paying the charge, and one copy of which is to be retained by the Clerk.

AMENDMENT shall become effective 30 days after publication in the Parma News.
