# AN AMENDMENT TO ORDINANCE NO. 147

# AN ORDINANCE FOR REGULATION OF TRAFFIC WITHIN THE VILLAGE OF CONCORD

At a regular meeting of the Village Council held in the Village Hall on the 14 day of November, 1989, at 7:30 pm, Eastern Standard Time, the following Amendment to Ordinance No. 147 was offered by Member Whiting and supported by Member Cecil.

BE IT GRDAINED AND ENACTED by the Village Council for the Village of Concord, County of Jackson, State of Michigan, that Ordinance No. 147 be amended to read as follows:

#### SECTION 1. ADOPTION

The Village of Concord hereby adopts Chapters 1, 8 and portions of Chapter 6 of the Traffic Regulations set forth in Act No. 300 of Public Acts of 1949, as amended, effective October 1, 1989, being the Michigan Motor Vehicle Code, and in particular all of the provisions of Act 514, Public Acts of 1978, for the regulation of traffic with the Village boundaries.

#### SECTION 2. REGULATIONS ADOPTED

The following regulations and sections of the Michigan Motor Vehicle Code are hereby adopted.

#### a. WORDS AND PHRASES DEFINED

The Village adopts Section 1 through 82, inclusive, of Chapter 1 of the Michigan Motor Vehicle Code.

#### b. OBEDIENCE TO AND EFFECT OF TRAFFIC LAWS

The Village adopts Section 601 through Section 709, inclusive, and Sections 727 through Section 750, inclusive of Chapter VI of the Michigan Motor Vehicle Code.

#### c. PENALTIES

The Village adopts Sections 901 through 909 of Chapter VIII providing for misdemeanor penalties not to exceed imprisonment for ninety (90) days, or fines of \$100, and civil infraction penalties not to exceed \$100.

### SECTION 3. PURPOSE

The purpose of this Ordinance is to adopt a code to regulate traffic within the Village of Concord, to provide for the health, safety and welfare of the residents of the Village.

#### SECTION 4. COSTS

Any person found guilty or held responsible for a violation of a provision of Act 300 of the Public Acts of 1949, as amended, shall in addition to the fines and penalties set forth in the Act be liable and responsible to the Village for the costs of prosecuting such violations. Such costs shall include but not be limited to Court appearance by officers, attendance in Court by counsel for pre-trails, motions and trials, and any other costs directly associated with the prosecution of the offense.

# SECTION 5. CODE AVAILABILITY

It further is ordained that the Village Clerk is directed and shall keep copies of the Michigan Motor Vehicle Code at the Village Office for inspection by and distribution to the public.

## SECTION 6. CODE SECTIONS

It further is ordained that the text of the Sections of the Michigan Motor Vehicle Code hereby adopted by Section 2 hereof shall be a part of this Ordinance Amendment and affixed hereto as an addendum and that the Village Clerk is directed and shall keep copies of this Ordinance Amendment at the Village Office for inspection by and distribution to the public.

# SECTION 7. SEVERABILITY CLAUSE

This Ordinance is hereby declared to be severable and should any part, provision or paragraph hereof be declared invalid by a Court of competent jurisdiction, it shall not affect the remaining provisions hereof.

All Ordinances, resolutions, or orders, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

## SECTION 8. EFFECTIVE DATE

This Ordinance Amendment shall take effect and be enforced from and after the earliest date allowed by law. This Ordinance Amendment and text of sections of the Michigan Motor Vehicle Code adopted by Section 2 hereof shall be published in the manner provided by law.
