AMENDMENT TO VILLAGE OF CONCORD
POLICE AND PUBLIC SAFETY ORDINANCE #141

At a meeting of the Concord Village Council held on August 11th, 2009, a Motion was made by Schafer and supported by Gretz, to adopt the following resolution:

WHEREAS Village of Concord Police Chief Steve Sinden has recommended that Ordinance #141 be amended to allow overnight parking on Village Streets when such would not interfere with snow removal from the Village streets; and

WHEREAS, it is no longer necessary to prohibit on-street parking as streets are no longer cleaned on a regular basis; and

WHEREAS, it is recommended that overnight on-street parking be prohibited only during the months of November, December, January, February, March and April;

NOW, THEREFORE, IT IS HEREBY RESOLVED that the attached Ordinance #141-A2009-1 be adopted.

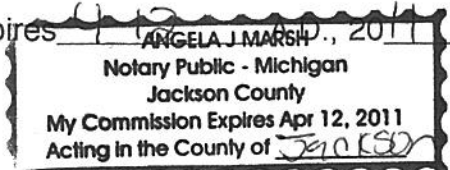
