

Section 6. The several officers named in this ordinance shall receive such compensation for their services as the Common Council may from time to time allow.

Section 7. Any officer who shall willfully neglect or refuse to do or perform any of the duties provided in this ordinance, and any person who shall willfully refuse to obey and perform the lawful orders or direction of any officer provided for in this ordinance shall upon conviction thereof, be punished by a fine of not more than twenty dollars and costs of prosecution, and in case such fine and costs are not paid, the court before whom such conviction is had may make a further order and judgment that the person so convicted shall be imprisoned in the county jail until such fine and costs be paid, for a term not exceeding twenty days.

BY-LAW No. XVII.

An Ordinance To Punish Offenses Against Public Decency.

The Village of Concord, Mich., ordains as follows:

Section 1. No person shall make any indecent exposure of any stallion, bull, or other animal, in any public places, nor within view of any dwelling, house, nor in any place where the same may be seen by persons passing or repassing, on any street, lane or alley in this Village.

Section 2. No person shall make any indecent exposure of his or her person, or engage in any lewd, lascivious or vulgar conduct in said Village.

Section 3. No person shall use any vulgar or indecent language within the hearing of any other person in said Village.

Section 4. No person shall show or exhibit for sale in said Village any indecent or obscene pictures, drawings, engravings, paintings, books or devices, or any written or printed papers, or other thing containing obscene, opprobrious, scurrilous, libelous or defamatory character, nor to make, or exhibit, any indecent or obscene show or exhibition of any kind in said Village.

Section 5. Any person who shall violage any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not less than one dollar and not more than fifty dollars and costs of prosecution; and the court before whom such conviction shall be had may make a further sentence or order, that in default of the payment of such fine and costs within a time to be fixed by said court, that the person so convicted shall be imprisoned in the county jail until said fine and costs be paid, for a term not exceeding sixty days.

BY-LAW XVIII.

An Ordinance For The Protection Of The Fire Apparatus Of The Village.

The Village of Concord, Mich., ordains as follows:

Section 1. That no person shall interfere with, or use, any fire engine, hose, fuel, kindling, or any apparatus, or materials, kept or used by said Village for the purpose of extinguishing fires, except such person shall have permission of the Common Council, or the Chief Engineer of the Fire Company.

Section 2. No person of sufficient ability present at any fire, shall willfully neglect, or refuse, to comply with any requirement of the President of said Village, Chief of the Fire Company, Marshal or Fire Warden, in aiding, or assisting in extinguishing such fire, or preventing any goods or property from being stolen or injured, or in protecting, removing or securing the same.

Section 3. No person shall willfully or knowingly, raise or
