curculate any false alarm of fire.

Section 4. No person shall cross or run over any hose with any vehicle while the same shall be in use by the Fire Company.

Section 5. No person shall interfere with or impede any member of the Fire Company, or any person while engaged in saving or protecting any property at a fire.

Section 6. No person shall willfully injure or deface any building used as a place of deposit for fire apparatus belonging to the Village.

Section 7. No person shall disturb any meeting of the Fire Company.

Section 8. Any person who shall violate any of the provisions of this ordinance shall, on conviction thereof, be punished by a fine of not less than five dollars, and not more than fifty dollars and costs of prosecution; and the court before whom such conviction shall be had may make a further sentence or order that in default of the payment of such fine and costs, within a time to be fixed by said court, the person so convicted shall be imprisoned in the county jail until such fine and costs be paid, for a term not exceeding sixty days.

Rever BY-LAW No. XIX.

An Ordinance Establishing A Pound And Restraining Animals From Running at Large.

The Village of Concord, Mich., ordains as follows:

Section 1. That the Common Council may establish a pound in said Village, and that a Pound Master who shall have charge of such point, and who shall take charge of and keep all horses, cattle, swine or other animals that may be brought to be impounded, and dispose of the same according to the provisions of this ordinance.

Section 2. No person shall allow, suffer, or permit, any of his, her or their horses, cattle, swing, or other animals, to run or be at large in or upon any street, common, lane or alley, within the limits of this corporation.

Section 3. It shall be lawful for any person, or persons, finding any of the aforesaid animals running at large contrary to the provisions of section two of this ordinance to take up and deliver to the Pound Master, at the pound, established by the Common Council, and any person so delivering said animal or animals shall be entitled to receive fifty cents per head for all horses and cattle, and fifteen cents per head for each and every other animal so delivered to the Pound Master at the pound, which fees shall be paid by the Pound Master to the person delivering said animal or animals to the Pound Master as aforesaid.

Section 4. The Pound Master shall not deliver to the owner any animal so impounded until such owner shall pay him twenty cents per head for the use of the corporation, for all horses, and cattle, and ten cents per head for all swine and other animals, and twenty-five cents per head to the Pound Master impounding for receiving and impounding the same, and ten cents per head for every day such animals shall remain in his custody, together with the fees paid by the said Pound Master to the person delivering said animals to the Pound Master, as is provided in section three of this ordinance.

Section 5. When any of the aforesaid animals are impounded according to the provisions of this ordinance, it shall be the duty of the Pound Master to whom the same are delivered, to notify the owner thereof personally, if known, within twenty-four hours after impounding the same, or by leaving a written notice at his place of residence, if within the corporation, or if not within the limits of the corporation by depositing the same in the postoffice to his address, or by either of the above methods.

Section 6. If no person shall appear to claim any of the aforesaid animals within three days after the impounding of the same, it shall be the duty of the Pound Master having charge of the same, to sell the same at public auction, on giving five days notice of the time and place of sale, by posting up written or printed notices in three public places in said Village, and such Pound Master shall receive for such notice twenty-five cents, and for selling any animal twenty-five cents.

Section 7. The proceeds of such sale after paying all costs, as charged in section three of this ordinance, together with the charge for advertising and sale shall be deposited in the Treasury for the use of the owner whenever he shall establish his claim thereto the satisfaction of the Common Council, if done within one year from the date of said sale.

Section 8. If any animal lawfully impounded shall escape or be rescued, the Pound Master from whom they shall escape or be rescued may at any time within twenty-four hours thereafter retake the same wherever it may be found, and hold and dispose of the same in the same manner as if no excape or rescue had taken place.

Section 9. If at any time previous to such sale the owner of said animal shall pay or tender to said Puund Master the fees and costs, so as aforesaid incurred, up to the time of the tender it shall be the duty of said Pound Master to accept the same and deliver the said animal to the owner thereof.

Section 10. No person shall hinder, delay or obstruct, any person engaged in driving or taking to the Pound any animal liable to be impounded.

Section 11. No person shall rescue any animal lawfully impounded for any cause, and no person shall bread open, or assist in breaking open, any Pound established in this Village.

Section 12. Any person convicted of a violation of the provisions of this ordinance shall be punished by a fine of not less than one dollar, and not more than twenty dollars and costs of prosecution. And the court before whom such conviction shall be had may make a further sentence, that in default of the payment of such fine and costs within a time to be fixed by said court, that such person so convicted shall be imprisoned in the county jail until such fine and costs be paid for a term not exceeding fifteen days.
