 An Ordinance To Prevent Injury To Or Destruction Of Shade  
 Trees In The Streets, Alleys And Public Grounds Of The  
 Village Of Concord.

The Village of Concord ordains as follows:

Section 1. No person shall cut down, mar, deface or uproot any tree standing in any of the public streets, lanes, alleys or other public grounds of the Village of Concord for any cause whatever, without first having permission from the Common Council of said Village, and then only in strict conformity with all the conditions and limitations of such permission. Any person violating the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not less than five dollars nor more than one hundred dollars, or by imprisonment in the county jail not more than ninety days, or by both such fine and imprisonment in the discretion of the court.

Section 2. It shall not be lawful for any person to hitch any horse or horses, mule or mules, or cattle, to any shade or ornamental trees in any of the streets, lanes, alleys or public grounds in the Village of Concord. Every person offending against the provisions of this ordinance shall upon conviction thereof, be punished by a fine not exceeding fifty dollars besides costs of prosecution, or by imprisonment in the county jail not exceeding sixty days, or by both such fine and imprisonment.

Section 3. It shall be the duty of the Marshal to enforce the provisions of this ordinance.

 By-Law No. VI.

An Ordinance To Prevent Nuisances And The Carrying On Of  
 Offensive Trades.

The Village of Concord ordains as follows:

Section 1. It shall not be lawful for any butcher or other person to keep, use or maintain any slaughter house, or other place for the slaughtering of animals within the corporate limits of the Village of Concord.

Section 2. It shall not be lawful for any person to keep, or suffer to remain in or about his shop, dwelling or any premises occupied by him, any offensive animal or vegetable matter within the limits of the Village of Concord, or to carry on any filthy or loathsome trade or occupation offensive to the public, or prejudicial to the public health.

Section 3. Every person violating any of the provisions of either of the preceding sections of this ordinance shall, upon conviction thereof, be punished by a fine not to exceed one hundred dollars, for each offense, besides costs of prosecution, or by imprisonment in the county jail, not to exceed ninety days, or by both such fine and imprisonment in the discretion of the court.

Section 4. It shall also be the duty of the Marshal to visit and inspect all places in the Village of Concord where he suspects or has reason to believe that any of the provisions of this ordinance have been or are being violated; and in every case where he finds any person in the actual violation of any of the provisions of such ordinance, it shall be his duty immediately to notify such persons to cease such violation, and also to report the name of such offender, the character of his offense, and whether the order of the Marshal has been complied with, to the Common Council at its next meeting. In case the person so offending and so notified by said Marshal shall neglect to comply with the request or direction of said Marshal to cease such offending or to remove the cause of such offense, it shall be the duty of such Marshal, by himself and his agents by him appointed therefor, to cause such offensive matter or thing to be removed and to be destroyed or buried

in some place so as not to be offensive or injurious to any person, and to keep an accurate account of the cost and expense incurred thereby, together with a reasonable charge for his own services, and to demand of all persons so neglecting or refusing to carry off, destroy or remove such offensive thing, payment of the amount so charged, and in case of the neglect or refusal of such party so offending to pay the amount thereof, to present the same to the Common Council of the Village, to be by said Council in the first instance paid out of the proper funds of said Village, the same to constitute a claim against said person or persons so offending, to be collected of such person or persons by suit in the name of the Village of Concord before any court of competent jurisdiction. And said person or persons so refusing or neglecting to comply with the order of the said Marshal shall also be punished, upon conviction thereof, by fine not exceeding one hundred dollars and not less than the amount of such costs and expenses incurred by said Village, as aforesaid, or by imprisonment in the county jail not exceeding ninety days, or by both such fine and imprisonment.

Section 5. If any person shall put any dead animal, or part of a carcass of any dead animal, into any mill pond, mill race, river, street, alley, lane, or, field, or common within the Village of Concord, except the same and every part thereof be buried at least two feet under ground, and if the owner or owners thereof shall knowingly permit the same, to remain in any of the aforesaid places to the injury of the health, or to the annoyance of the citizens of said Village, or any of them, every person so offending shall, upon conviction thereof, pay a fine of not less than five dollars nor more than twenty dollars, together with the costs of prosecution, or by imprisonment in the county jail not exceeding twenty days, or by both such fine and imprisonment in the discretion of the court.

Section 6. It shall not be lawful for any person to throw, place or deposit, or to cause or permit to be thrown, placed or deposited upon any sidewalk, or in or upon any street or alley within the limits of said Village, any slops, urine, carrion, or filthy substance; or cause or permit the same to pass through any sink, spout or drain on to any sidewalk, or into or upon any street or alley with the corporate limits of said Village; and every person offending against the provisions of this section, shall, upon conviction thereof, be punished by fine not exceeding fifty dollars, besides costs of prosecution, or by imprisonment in the county jail not exceeding sixty days, or by both such fine and imprisonment in the discretion of the court.

Section 7. No person shall place or deposit any stones, gravel, dirt, logs, sticks, or other things in any stream of water within the limits of said Village, or in any manner dam up, obstruct or hinder the free passage of water in any river or stream within the said Village, nor deposit or place in said river or stream of water or in any mill pond or mill race within the corporate limits of said Village, any filthy, offensive or impure matter, animal or vegetable, or any substance whereby the water may be obstructed in its flow, or shall be rendered filthy, unwholesome or corrupted. Every person violating any of the provisions of this section shall, upon conviction thereof, be punished by a fine for each offense in a sum not exceeding one hundred dollars, besides costs of prosecution, or by imprisonment in county jail not exceeding ninety days, or by both such fine and imprisonment in the discretion of the court.

Section 8. It shall be the duty of the Marshal to see to the enforcement of all the provisions of this ordinance.
