An Ordinance To Regulate The Use Of Streets, Alleys And Sidewalks Of The Village Of Concord.

The Village of Concord ordains as follows:

Section 1. It Shall not be lawful for any person to leave any horse or horses in any of the public streets of said Village unless securely tied; and any person offending against this provision shall upon conviction thereof, pay a fine not exceeding five dollars besides costs of prosecution.

Section 2. No person shall place, or cause to be placed, any stone, brick, timber, lumber, or other material, in or upon any of the streets of said Village, without leave first had of the Common Council, and then in strict compliance with the conditions and limitations of such leave. Any person offending against the provisions of this section shall, upon conviction thereof, pay a fine not exceeding twenty dollars and costs of prosecution.

Section 3. Every owner or occupant of premises in the Village of Concord shall at all times keep the drain or gutter in front of such premises free from all obstructions that may hinder the passage of water. Every person offending against the provisions of this section shall, upon conviction thereof, pay a fine for each offense not exceeding five dollars besides costs of prosecution.

Section 4. No person shall place or deposit, or suffer his or her agent, servant, child, or any member of his or her family, to place or deposit any dung, dead animals, carrion, putrid meat, fish, entrails, decayed vegetables, decayed fruit, wood, straw, hay, or other thing in any street, lane, alley or public ground in the Village of Concord, or place any nuisance, or store or keep any vehicles or other property therein. Every person offending against the provisions of this section shall, upon conviction thereof, be punished by a fine of not exceeding fifty dollars besides costs of prosecution, or imprisonment in the county jail not exceeding sixty days, or by both such fine and imprisonment in the discretion of the court.

Section 5. No person shall run or race any horse or horses within the Village of Concord, or drive any carriages or vehicles of any kind within the limits of said Village at a rate of speed faster than six miles per hour. Any person violating the provisions of this section shall be punished by a fine not exceeding twenty dollars and costs of prosecution, or by imprisonment in the county jail for a period of not exceeding twenty days or by both such fine and imprisonment in the discretion of the court.

Section 6. No person or persons shall, unless first authorized by the Common Council, dig, remove or carry away any earth, loam, sand, gravel, sod or stones from any street, alley or public ground in the Village of Concord. Any person violating the provisions of this section shall, upon conviction thereof, be punished by a fine not exceeding fifty dollars, or by imprisonment in the county jail not exceeding sixty days, or by both such fine and imprisonment in the discretion of the court.

Section 7. No person shall ride or drive any horse, mule, cattle, or other animal, upon or along any of the sidewalks in such Village, and every person violating the provisions of this section shall, upon conviction thereof, be punished by fine not exceeding twenty-five dollars, besides costs of prosecution, or by imprisonment in the county jail not exceeding thirty days, or by both such fine and imprisonment in the discretion of the court.
