**OFF DUTY POLICE RELATED SITUATIONS HANDLED**

9 in the village and 6 in the township - 15 TOTAL

June 1: I worked with Animal Control to try and capture two aggressive German shepherds at the Carr Bros. facility on Elm Row Rd. These two dogs have been reported throughout the area (including Parma) for chasing livestock, etc. Last update was the dogs have avoided capture and remain at large.



June 3: In the on-going saga of cats near the post office, several citizens were concerned that a stray cat may be trapped inside the old Thorrez building on Main St, which was recently sealed up. There is nothing, at this time, to indicate any cats were entombed inside the building.



June 7: I assisted a deputy in Parma on a domestic assault call on W. Michigan Ave.



June 8: Units responded to an address on King Rd. for a heroin overdose. The subject was transported to the hospital for medical treatment.



June 8: A pre-school aged child pulled the fire alarm at Concord Elementary School.



June 8: It was reported that the music from the Cadet was too loud and bothering residents. I was in the area when this call came in and there was nothing to substantiate the complaint.



June 9: I assisted the Spring Arbor Police Department on Lockerbie Road on a mental health and domestic debacle that involved multiple family members and some neighbors. This situation hasn't been resolved yet and I've since returned with them 3 additional times. God help us all.



June 10: I responded to an address in the township for a case involving a probation officer and his family being threatened by a subject recently released from jail.



June 11: A female subject on Bath Mills Rd. was arrested for felonious domestic assault.



June 13: Subjects living in an RV trailer on Bath Mills Rd. were cited for doing so. This is a long, ongoing situation that will continue.



June 14: I handled a mental health call in the village in which a male subject was making suicidal statements after a recent breakup.



June 15: A GPS track reported that a suicidal woman was in a vehicle in a field on N. Concord Rd. @ Warner Rd. Apparently, she was waiting for the sun to go down prior to killing herself. I was not able to locate the subject – or her vehicle – anywhere in the area.



June 16: Subjects spray-painted vulgar words and shockingly crude images on M-60 & Main St. in the village as well as a location down in Pulaski. The images were ultimately power-washed away by the Jackson County Road Commission. The images were not anatomically correct.



June 18: A subject along the river near Albion Rd. reported two kayaks abandoned on her property. Twenty-four hours later, they were gone.



June 19: I responded – along with the fire department – to an address on Hanover St. for a burn investigation.



June 23: I assisted Animal Control and another county unit at Swains Lake Park for a significant dog bite. A 6 y/o girl approached a large dog and apparently startled it, causing it to turn and bite her, puncturing both her upper and lower lips. Animal Control handled the investigation.



June 25: A wayward, vagabond couple – a white female and a black male – had been kicked out of Swains Lake Park on June 22 for engaging in sexual acts in the gazebo. Eventually they simply walked away...

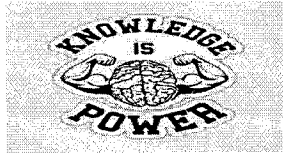
... and found their way to Concord, where they spent a couple of days sleeping where they could and lying facedown along the road.

On June 25, the male suffered a drug-induced, sleep-deprived breakdown of some sort, stripped naked and began running in and out of traffic. Ultimately, he broke into a storage shed and barricaded himself inside, fearful of bugs and robots.

He was eventually removed from the shed and transported by ambulance to the hospital for a bevy of medical issues.

The female was given a ride – courtesy of the sheriff's department – to a location in Calhoun County where we are hopeful she will remain.
